Expression of Interest

1. Expression of interest is invited by National Vocational & Technical Training Commission (NAVTTTC) from technically qualified and financially sound Public/Private Technical & Vocational Training Institutes and private (small, medium & large) Industries to run 03 to 06 months training programme under Prime Minister's Youth Skill Development Program (Phase-IV).
2. An applicant institute must be Registered / Affiliated under respective Provincial Technical Education & Vocational Training Authority (TEVTA) / National Training Bureau (NTB), Board of Technical Education (BTE), Trade Testing Board (TTB) or HEC recognized University. Whereas, an applicant private industry must be registered under Industrial Act or have the membership with local Chamber of Commerce & Industries and contain an Industrial Training Unit.
3. The rate of training may fluctuate and will be offered in pursuance of applied trade and assessed capacity of institute/industry. The trades should be selected out of provided trade list. Assessment criteria (to be filled) and trade list may be obtained from NAVTTTC website: **www.navttc.org**
4. The institutes are required to apply on NAVTTTC's online Project Monitoring & Management System (PMMS) link: **175.107.15.234/navttc** (also available on NAVTTTC's website) by 31st of July, 2017. The hardcopy of filled Assessment form alongwith the supporting documents must also reach at below mentioned (concerned) Regional Offices at provincial level by 31st of July, 2017 till 1100 hrs. Incomplete application forms not supported with requisite documents or not applied on online portal will not be entertained. EoI will be opened at 1400 hrs at same date.
5. The information should also include full particulars of institutes on envelop i.e. Name of institute with complete address by mentioning the District, Division and the applied trade(s). The process shall be governed under the Public Procurement Regulatory Rules and NAVTTTC reserves the rights to reject any application prior to the acceptance on the basis of NAVTTTC's prescribed criteria.

Note: The applicant Institute possessing Boarding & Lodging facility must clearly specify the capacity & requisite provisions alongwith photographs in application
