

National Vocational & Technical Training Commission (NAVTTC) is an apex body at national level to regulate, facilitate and provide policy directions in vocational and technical training. NAVTTC invites eligible and interested individual consultancy firms, universities and research organizations having specialization in Monitoring and Evaluation (M&E) of different programs for evaluation of PMYSDP Phase-IV. Responding firms/ organizations may provide verifiable information indicating that they are qualified to perform the Evaluation of the program. The interested firms/ organizations who meet the below mentioned eligibly criteria are invited to submit their expression of interest including technical and financial proposals.

- Be registered under respective governing laws and must have valid GST and NTN. 1.
- 2. Not be blacklisted by SECP, PPRA or any other government body (all the bidders must provide affidavit to this effect).
- 3. For firms, other than universities and research organizations, at least 05 year experience of working in TVET sector.
- Have 05 years of experience in M&E preferably in the Education sector. 4.
- Be based/head office in Islamabad and should have outreach in far flung areas of Pakistan. 5.
- 6. Automated systems of evaluation, data collection and impact analysis.
- All proposals should bear the signature of authorized person on each page. Hand written and proposals with 7. overwriting will not be considered.
- The last date for receipt of EOI/RFP is 22nd January 2018 before 11:00 am. EOI bids will be open on 8. 22nd January 2018 at 11:30 am
- All the bidders should submit earnest money/bid security @ 2% of bid value (financial bid) in the shape of Pay Order/ Demand Draft in favour of "DDO NAVTTC, Islamabad". Firms failing to meet this condition will not be considered.
