- A Committee may be constituted at respective Regional Offices, for carrying out the assignment. The Committee may be flexible while scoring the institute in less developed area of the country.
- The rating against each parameter must be undertaken as a = Maximum , d = Minimum, e = 0
- Applicant Institutes are required to attach the documentary & pictorial evidences with application
- Institutes are required to tick the exact/suitable category (a, b, c, d or e) and encircle the weightage given at right side accordingly
